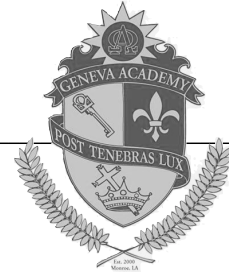

**PARENT/STUDENT AGREEMENT**

Now appears the undersigned individual, who is the parent or legal guardian for the student identified on the other side of this agreement (hereinafter "parent"), who appears herein for the purpose of memorializing certain agreements with Geneva Academy, Inc. (hereinafter "Academy"), for the designated school year, viz:

1. The Academy is a nonprofit corporation and private school, receiving no local, state or federal funds or support, directly or indirectly, established for the purpose of providing a Christian classical education for students, and the parents wishes to enroll his child as a student in the Academy.
2. Classes will be held in conformity with the schedule to be released by the Academy.
3. Students are expected to attend every class for which they are enrolled, unless providentially hindered. Any student who will miss class is required to notify the instructor(s) **in advance** of his absence and the reason for same (unless providentially hindered). Any student missing a class will be responsible for obtaining the material or information missed.
4. To secure payment of instructor contracts, each student at the Academy will be assessed a fee established by the Board of Directors of the Academy. The fee shall be payable in an annual lump sum or for ten (10) consecutive months from August of the beginning of the school year through May of the next year. Monthly rate schedule:

**TUITION 2013-2014**

Secondary students (7-12)	\$500.00 / mo (Aug – May)	[Plus cost of books and rentals, usually c. \$200 per year]
Elementary (K-6)	\$400.00 / mo (Aug – May)	[Plus activity / book fee of \$200.00 per year]
Pre-K	\$160.00 / mo (Aug – May)	[Plus activity / book fee of \$100.00 per year]

**The monthly fee is due and payable no later than the 1<sup>st</sup> day of each month. A late fee of \$20.00 will be assessed for fees not received by the 5<sup>th</sup> day of the month. Each family is responsible for paying the complete annual fee set by the Board, even if the student is absent, suspended or dismissed for any reason. A 25% discount will be given for a third student in a family enrolled, and a 50% discount will be given for the fourth, fifth, etc., students in one family. The discount will be based upon the lowest tuition(s) assessed.**

5. Students will be responsible for purchasing books and other materials not provided by the Academy.
6. By this agreement, the undersigned parent agrees to the terms set forth herein and to abide by the rules and guidelines of the Academy, as implemented and enforced by the Board, Headmaster and instructors. The undersigned parent also agrees to the use of above student's photograph being used in school publications and advertising.
7. The undersigned individual agrees that the instructor(s) and Headmaster of the Academy may use reasonable corporal punishment upon the students as they deem necessary.
8. Parents affirm the biblical duty to avoid gossip and slander. Offenses are to be handled in accordance with Scripture by bearing with one another and in dealing privately with perceived offenses. If private confrontation does not resolve the conflict, the matter is taken to the Headmaster or Board of Directors, as is appropriate.
9. Parents acknowledge the authority of the Academy to suspend or dismiss a student for reasons deemed appropriate by the Academy. Appeal may be made to the Board of Directors for any suspension or dismissal. If a student is suspended or dismissed, this shall have no effect on the tuition due the Academy for the school year. The Academy may unilaterally revoke this contract, at its discretion, if it reasonably believes that is necessary.
